## Wealth Suite » ESG - Sustainability Score

**Sustainability Details:** When for a portfolio sustainability preferences have been defined, key figures are displayed for such positions in valuation and compliance pages. A dedicated sustainability scorecard shows in all ordering page the ESG score with including pending orders.

**NOTE:** The enhanced package solution for the ESG indicators related to 'EU Taxonomy' and 'PAI' metrics is applicable to the non-mutual funds (The MF data structure is not available currently) instrument universe only.

Portfolio Sustainability score is added in Multi-Ordering pages as well. In the Multi-Ordering flow, the Compliance Summary has two sections "Global" & "Per Portfolio". ### Wealth Suite » Batch Reporting

With Batch RESTful APIs you can easily generate report for a large list of Portfolios with a good efficiency.

It is an asynchronous REST service. This means that data will not be returned immediately in a request response but will be delivered to an object storage.

The processing uses the Job Launcher and TSL Frameworks for the parallelisation.

The batch processing API comes with the set of REST APIs which support:



- Creation of batch reporting for an execution.
- Monitoring the statuses of a batch.
- Getting the reports one by one.
- Getting the collection of reports in one call.
